Spring has now sprung; however, all areas remain sodden. The contractors had started to cut areas but unfortunately the ground is still wet.

Storm Katie had caused a large branch to dislodge on Stokes Green and the Clerk had this removed urgently.

Councillor Wilson reported small holes around the tree trunks on Cokes Green, maybe voles and will keep a watch.

Memorial Hall

The Clerk had forwarded all emails received for the works being carried out at the Memorial Hall. The Clerk has asked for a statement of account for the Public Work Loan account.

Councillor Cave reported all works had been completed and looked good. The interior decoration was next and advice is being taken on the best colour scheme for the ceiling in the main hall. The area at the back is still needing attention but a solution could be gabion baskets, this is still ongoing.

- 9. Island Roads, Annual asset meeting, once again this was a good meeting informing all of upcoming works.
- 10.Open Spaces

Turvills Field; Clerk contacted contractors after last month's meeting regarding brush cutting Turvills Field, this will be carried out as soon as area dries up but they have been keeping an eye on it.

Turf Walk; The hedges were cut at the end of February.

Colwell Common; contractor has been notified to cut the Common regularly.

Contractors have also been given event dates including Best Kept Village Awards and the Clerk will meet to discuss next phase of tree works.

- 11.Dog Bin; An order has been placed with Island Roads for new installation of bin at the top of Widdick Chine at a cost of £249.60. Councillors agreed the bin should be placed by the existing post.
- 12.Skate Park; the committee will meet on Monday 18th March and discuss the recently received quotation for maintenance work. The quotation is over £600.00 plus materials and Clerk advises further information should be sought as to whether this is maintenance under Health & Safety or further upgrading.
- 13.Clerk and JH had been invited on to the Our Place Committee which has been set up by Freshwater Parish Council. The Clerk attended this meeting earlier this evening and was upbeat about the plans. The service they want to offer is similar to what Totland Parish Council office already offers just by having the office on the main road. The Committee are hoping to have a co-ordinator who will be based at the Sport and Community Centre; this person will be able to help residents of Freshwater and point them in the right direction for any help they may require. Guest speakers included Westview Hub of Totland; -Westview are holding a coffee morning on Saturday 23rd April and Pharmacy First which encourages residents to talk to their local Pharmacist about their needs on minor ailments rather than trying to obtain a Doctors appointment.
- 14.Clerks overtime from 1st December 2015 to 31st March 2016 (4 months) the Clerk has worked an addition 25 hours overtime, this has primarily been on the Public Toilets meetings, gaining information

and working with other agencies for the toilets to remain open from $1^{\rm st}$ April legally – obtaining legionella risks etc. Insurance costings and rebuild costs.

Helping residents of both Totland and Freshwater with their Council Tax problems. Residents have found it particularly difficult getting hold of this department this month.

The new black bins are also causing concern, some don't want a bin but have been told they will have one. Several re-appraisals have been requested for residents again of both Freshwater and Totland.

Councillors agreed the Clerk should be paid for this overtime. Clerk thanked Councillors.
