The scale and mass is excessive for this environment and Councillors will encourage people to object to this application based on the quality of design.

152/18 QUOTATIONS

To discuss and accept tree quotations as attached.

Three quotations had been received and Councillors agreed with the lowest quotation. Councillors also agreed to have W Green on site for additional labour. Councillor Wyre and Fennell would make themselves available as banks people as required.

RESOLVED to accept quotation £3408.00 for tree works. Proposed Councillor Howe, seconded Councillor Fennell all agreed.

Any other Business

Councillor Howe has been working with Island Roads and is very concerned with the traffic problems around Alum Bay Old Road. Buses and coaches use this route from Freshwater Bay and he would like to work on a resolution with Island Road to deter holiday traffic heading down Alum Bay Old Road and direct to Alum Bay New Road. Councillors supported this action and agreed to explore options for this. As the summer season is upon us now it was suggested a road closure sign is displayed, this would stop holiday traffic entering and an easy quick solution. Councillor Howe would take this back to Island Roads.

It was also suggested a letter was displayed on the coach parks notice board at Alum Bay reminding them not to use this road on their return trip. Councillor Howe will be meeting on Friday and would ask the Park to arrange this.

Councillor Cave had not heard back from Island Roads regarding coaches reversing down Colwell Chine Road. Councillor Howe had spoken to The Hut who were informing coach customers they should park at Colwell Common and customers to walk down.

We have the National Trust coming to the July meeting and Councillor Blamire would ask if they would consider a sign on the entrance of the Warren stating no BBQ's in this area.

Madeira Road needs vegetation cutting back. This includes both trees and low hedges. Heath Meadows path also needs cutting back.

Anti-social behavior – Turvills Field, youth had been in the area smashing bottles and lighting fires. The container on Colwell Common had been graffitied along with the bus stop. The Clerk had arranged for the container to be cleaned and Island Roads dealt with the bus stop. Kids have managed to get on top of the container and had also tried setting fire to a tree. The Police will meet with the Clerk next week to discuss further. The Clerk suggested using Anti Climb paint around the top of the container ensuring proper signage is placed, the police support this idea and to plant a fast-growing climber. Councillors agreed and thought a Pyracantha would suit this best. Clerk would obtain a cost for trellis and Pyracantha and anti-climb paint.

The Hut – a couple of Councillors had been contacted by residents to the overspill of the Huts customers onto the seawall and that they had witnessed them throwing bottles into the sea. They had felt intimidated trying to pass them as many are drunk. Clerk to inform the Hut. Councillor Howe will speak to the Isle of Wight Council.
