- A deck chair had sunk into the sand at Colwell and the Environmental Officer had removed this today.

Councillors agreed to a 1 year Memorandum of Understanding for the Totland Men in Sheds who will be running from the Turf Walk. The Clerk confirmed that the West Wight Men in Sheds will run from the Recreation Ground and it has been agreed to a 10 year lease.

The Clerk explained the Common was in Totland and the Car Boots were fenced off and money received was used to maintain the Common. **NOTED**

Three emails have been received from residents around Moons Hill regarding the T24 bridleway proposals. A copy of the proposal and signatures supporting this to be stopped had been handed to the Clerk for Councillor Howe. I had explained this was not the Parish Councils decision and that the land belonged to National Trust. Councillor Howe would speak to these residents to confirm the details.
