2. Open Spaces

Urgent tree works are required on Colwell Common. The willow on the upper section, several branches are down and as a result these need clearing, and a silver birch is dead on the lower section and needs to be removed. The cost for both jobs including clearing will be no more than £600.00. Councillors agreed for these works to go ahead due to the urgent nature. **RESOLVED**.

3. Clerk

Public Toilet Committee are working towards project managing this themselves due to the cost involved, further information will come back to Councillors in due course.

Three consultation events have taken place for the Cycle Skill Park on Totland Recreation Ground.

Totland Men in sheds have returned keys for Cliff Road shed.

The handrail has been repaired to the steps on Stokes Green with additional works required.

Tree branches will be removed during December in Turvills Field which are hanging over Greenways gardens.

Local Cycling and Walking Improvement Plan

An email had been circulated regarding this project. Councillors discussed their input to this and agreed the information that has been shared was considered 'not enough to make an informed decision' which was required by 15th November. Councillors were also very uncertain how this would work for Totland. Councillors also agreed the local community through the Parish Council have taken a lot of responsibility from the Isle of Wight Council over the last 10 years and work hard improving their own facilities whilst benefiting the Island as a whole.

Councillor Medland had agreed with Freshwater Parish Council to make this bid on behalf of the West Wight Councils', however, he has no authority to do this as he is committing to an unknown expenditure which Parish Councils will be required to match fund.

Biffa have removed the waste from School car park at a cost of £91.00.

Maintenance person will start during January 2022.

Parking – The solicitor cannot act on behalf of the Parish Council as there is a conflict of interest. Clerk could set up an agreement if Councillors approved. Councillors agreed to this.

4. Memorial Hall

The agreed works have commenced, however, there are further problems with the building. GW as Chairman of the Memorial Hall Committee will arrange necessary quotations and bring back to both Parish Councils for approval. The Clerk will forward original quotations for the works carried out in 2018.

5. West Wight Group of Councils

The group met last week, and draft minutes have been circulated. Points discussed:

Both Newport & Carisbrooke Community Council and Shalfleet Council had

 purchased speed cameras for a Community Speed Watch, however, both were finding it difficult to find volunteers to attend training and run. At any time, this would need 5 people to operate the event. The Clerk had not received any complaints regarding speed in Totland for some time. Bob Seely MP was also in attendance and spoke about the Island not having its own Road Policing Unit (RPU) and urged all to write a letter to him supporting this in order to clamp down on speeding and uninsured drivers. Councillors agreed for the Clerk to send a letter supporting this. The Isle of Wight Road Race event is back next year, and Brighstone Parish Council would like to know of any concerns each Parish Council had in order that they can add to their report. Councillors had no concerns.

6. Remembrance Service

This year's Remembrance Service will be at Totland War Memorial on Sunday 14th November and Councillor Cave will lay the wreath for Totland Parish Council. The Clerk spoke with the Parish Council insurance company, and they agreed this would come under Public Liability. The roundabout had been tidied at a charge of £60.00.
