#### **PLANNING** 3.

a. To consider and comment on the following Planning Applications:-

Former Totland Waterworks Site Cliff Road Totland Isle Of Wight

Ref. No: 21/01380/FUL

Proposed detached dwelling with vehicular access, parking and landscaping (revised scheme)

Comments: This site is within the AONB and the impact remains the same as the previous applications. This development will not enhance the landscape. This site has now been cleared of trees and hedges and the wildlife has not been protected.

The stability of the cliff needs to be considered, a depression in the field behind over the last year is a concern and it is felt this area is now more vulnerable.

The drainage remains a problem with surface water running down Headon Hill into Cliff Road and down to the esplanade.

The proposed application is not in keeping with this area.

#### b. Broadway House The Broadway Totland Isle Of Wight

Ref. No: 21/01432/FUL

Proposed change of use of unit from wellbeing centre and café (sui generis use) to Class E (Commercial, business and service uses) and associated store room.

Comments: No comment providing this remains as commercial use.

c. Hawkridge Manor Farm Uplands Road Totland Bay Isle Of Wight PO39 0DZ

Ref. No: 21/00752/FUL

Change of use of paddock to be used as residential garden to include creation of tennis court and pool (tree report received)

Comments: Councillors have already commented on the works that had started

prior to this application. The flooding down Summers Court, Summers Lane and Court Road remain a concern with the landscaping that has already happened.

Tree Works - To note

4C Fairfield Way Totland Isle Of Wight PO39 0EF

Ref. No: 21/01363/TW

T1; Oak - Crown lift to 5 metres. To increase light levels in the garden whilst retaining prominent landscape tree. T2; Oak - Fell to ground level. Tree is being out-competed by neighbouring Oak and is in decline. There is not sufficient space within the garden to replant another tree. T3; Leyland Cypress - Fell to ground level. Tree of low amenity value and removal will give neighbouring Cherry more room. T4; Ornamental Cherry - Fell to ground level. Tree is of poor form and competing with neighbouring Cherry for space.

Elm and sycamore group - pollard at pre-existing points to manage as compact specimens on bank at rear of property.

Egan House Madeira Road Totland Isle Of Wight PO39 0BJ

Ref. No: 21/01336/TW

T1; Ash (Fraxinus Excelsior) - Dismantle. Tree contributes little to landscape and is now encroaching property and causing excessive shade. T2 and T3; Sycamores (Acer Pseudoplatanus) - Dismantle. Trees contribute little to landscape and are now encroaching property and causing excessive shade.

### 4. Draft Island Plan

To discuss actions for the Draft Island Plan <a href="www.iow.gov.uk/planthewight">www.iow.gov.uk/planthewight</a> A further meeting will be held to discuss fully, however, Totland is manageable compared to other areas around the Island. Weston School Field which has been maintained by the Parish Council and used by the Community and youth for 4 years should not be part of this plan.

A quotation has been arranged by the Memorial Hall Committee and Rowan Services was agreed. Clerk will inform the Memorial Hall manager. Cost to the Parish Council as a 1/3 owner £1225.00.
