Demolition of garage; proposed detached bungalow (revised scheme)

Comments: Councillors had no objections to the 2023 application and although this is a revised scheme it is noted that the reasons for the refusal do not seem to be taken into consideration.

Should this application be granted, Councillors would request that a condition be attached regarding the use and maintenance of the unadopted road. Given that The Mall and adjoining road, Uplands, are unadopted and not maintained by the local authority but the residents, and that such roads are prone to potholing and worse, Councillors would wish to see an enforceable condition placed on contractors to keep these roads in a passable condition throughout the construction period and to leave them in good order upon completion.

T1; Beech Tree - Fell Reason; T1 is suffering from 'Miripulus gigantus' around the base of the tree. There is further similar fungal growth up the trunk indicating rot within the trunk. The tree is within close proximity of 2 residential properties T2 & T3 both Sycamore Trees - Fell. Reason; Both trees are suffering loss of leaf and increase in dead wood within their crowns. T2 has significant bark lifting and rot within the central trunk. Both trees lean over towards Madeira Road and the risk of danger to road traffic if they fall is considered high.

T1; Oak (Quercus robur) -

Overhang to No.1 Fairfield Park - Tertiary boughs horizontal and/or pointing downwards removed up to 5M from ground level; Reduce over extended upper part of canopy approx 2M.

Overhang to No.13 Fairfield Way - Remove tertiary boughs horizontal and/or pointing downwards upto 5M from ground level.

Overhang to No.15 Fairfield Way- Prune back lower over extended section to match in the canopy; Remove tertiary boughs horizontal and/or pointing downwards upto 5M from ground level; Crown thin approx.10%.
